Employee Spotlight: Teri Stripes

The City's <u>Brownfields Program</u> helped connect the Spokane Low Income Housing Consortium (SLICH) to a U.S. Environmental Protection Agency (EPA) Brownfield grant opportunity that led to a \$500,000 award for the Spokane Land Bank, properties dedicated toward low-income housing. Target areas for the grant are the Northeast, East Central and West Central Spokane. "This opportunity only came about because of (City Economic Development Planner) Teri Stripes and the City of Spokane's Brownfields Program," SLICH Executive Director Ben Stuckart said. "We are so appreciative of our partnership and the opportunities that arise because of the great work with our community collaboration." Read the EPA press release here.

City Hall Construction

The contractor began work on the west roof (above the loading dock) today. All loading and off-loading of materials and debris will take place prior to 7:30 a.m. each day to allow the west lot to remain operational during normal business hours. It is anticipated that this work will take approximately one week to complete.

Upon completion, the contractor will be begin the process of removing the crane and overhead scaffolding protection, allowing for Post Street to be opened again for parking. Please feel free to contact the Facilities Department with any questions.

Pride Parade Saturday

The Spokane Pride Parade will be held on Saturday, June 10, at 12 pm beginning from Stevens St. and Spokane Falls Blvd.

Washington Cares Act (Long-Term Care Tax) Update

The Washington Cares Fund is the mandatory long-term care insurance benefit for workers in Washington state which will help pay for eligible long-term care related expenses. The program will be funded by a mandatory payroll tax by workers in Washington state beginning Saturday, July 1, 2023.

Unless you have purchased a qualified plan that enables you to "opt out" of this tax or you meet an alternate exemption, you will be required to participate in withholding of the tax. <u>Click here</u> to learn more.
